Entry fees

Categories with Finnish Basic Star Evaluation (Chicks)	15 €
Categories with Finnish Extended Star Evaluation	25 €
Categories with ISU evaluation, Springs A only FS	40 €
Categories with ISU evaluation, Novice B, Debs A, only FS	45 €
Categories with ISU evaluation, two programs	60 €

In addition, the judges' fees and expenses will be allocated to the participants as is customary in Finland.

For foreign competitors and adult skaters the expenses are included in the entry fee:

Categories with Finnish Star Evaluation	40 €
Categories with ISU evaluation, only FS	55 €
Categories with ISU evaluation, two programs	80 €

Cancellations

After 6pm on February 10th 2019, only cancellations verified by a medical certificate will be refunded.

Draw

The draw will be held at 6pm on February 24th at Riihimäki Ice Rink. The draw will be made by a random number generator in Finnish Star Evaluation categories and by ISU Calc program in ISU categories. The result of the draw will be published on the competition website on February 25th, 2019.

Awarding

Three first standings of each category/class will be awarded with a cup. All participants will receive a diploma. Award ceremonies will be held as soon as the results are confirmed.

Music

CD (**no re-writable discs**) or USB memory stick. All competitors must have a spare competition music CD immediately available during their performance.

Planned Program Components

Entries in ISU-categories, please attach the planned program component sheet (Annex E) to entries. All planned program component sheets must be delivered by email to address easterskate2019@gmail.com **by latest February 15th.**

Judges

The Organiser will invite the judges and the other officials. In addition, the judges' fees and expenses will be allocated to the participants as is customary in Finland. The names of the judges and technical panel will be published on the competition website.

Expenses

The Organiser cannot pay any expenses for the participants.



Protests

Protest must be submitted to the Referee of the category at the latest immediately after the category. The protest fee is 15 €. The Referee's decision is final.

Protocol

The protocol / list of results in each category shall be published on the competition website. the Organiser shall not provide print-outs or CD's.

According to the ISU Regulations, Rule 119, the Organiser accepts no liability for injuries or damage sustained by competitors or officials.
